**User Choice Funded – Queensland Government (Traineeships)**

Traineeships are funded by the Queensland Government under the User Choice Policy 2022-2023. User Choice provides a public funding contribution towards the cost of training and assessment services for eligible Queensland Apprentices and Trainees. Student contribution fees are set under this policy at \$1.60 per nominal hour. These fees will be reviewed annually by the Queensland Government and may be altered at various times throughout your training at their discretion. In circumstances where a student undertakes more than one apprenticeship or traineeship at the same time, the student will only receive funding for the government contribution fee for the qualification nominated in the first Training Contract registered.

**The total funded amount is \$6,040 for this qualification (excluding Student Contribution Fees)**

Please Note: Apprentices and Trainees, including SATs (School-Based apprenticeships-traineeships), can only receive a maximum of two government funding contributions under the current User Choice Policy.  
Students will be notified in writing if any changes to the student contribution fees are made

**Non-Funded Full Fee**

Students enrolling into the Fee for Service will be invoiced in increments as they progress through their training (This is detailed within in the participant handbook) The \$600 Enrolment and Resource Fee will be invoiced at time of enrolment.

Once payment has been received AADA will organise practical components of the course to be assessed in the workplace. All Students must complete min 350 hours of work either vocational placement (non-paid work experience – AADA will assist with finding a placement however students are required to contact Industry as well to endeavour to find a placement) or paid work within a Dental Practice

RPL – Formalise your Skills Program – it is recommended to be eligible for RPL that you have worked within the industry previously/currently.  
Please speak with an AADA staff member to confirm eligibility.

**Certificate 3 Guarantee** - Queensland Government funded.

The Certificate 3 Guarantee supports eligible individuals to complete their first post-school Certificate III qualification. The Co-Contribution fee may be paid on behalf of the student by the employer or another third party, but the fee cannot be waived by the RTO.
